The following topics/grievances /cases **shall not be entertained** during the online meet:

- i) Cases involving purely legal point e.g. succession etc or any matter which are sub-judice.
- ii) Grievances involving Policy Matters (Government of Maharashtra and /or Government of India).
- iii) Issues such as appointment on Compassionate Ground.
- iv) Retention of quarters after retirement and recovery of Penal/damage rent and matters relating thereto.
- v) Grievances already settled/under litigation will not be considered.

Applicants are requested not to submit any documents through WhatsApp but instead to use email or the postal services to send any data regarding their particular pension case.
