The celebrations included release of the third edition of '*The Catalyst* - a Compendium of Best Practices', release of 'Brochure on the Certification Course for Accountants of Panchayats and Municipal Bodies', Prize distribution for National Online Essay Writing Competition 2023 for the youth, Valediction ceremony for the IA&AS officer trainees of the batch of 2021 and recognizing innovative and meritorious work carried out by the Institution.
