

Subject : Submission of a signed statement by the Nagaland Government pensioners/family pensioners drawing pension/family pension in this state, for compilation of database.

In continuation to this office circular No. Pen. Co-ordn./Nagaland/Vol.-V/List-Pensioners/235 dated 14-02-2019, this is to state that the Government of Nagaland in their letter No. FIN/PCELL/GEN-2/2017-2018/11 dated 25-07-2019 has decided that in order to facilitate genuine pensioners who are unable to furnish the prescribed documents earlier prescribed at para 2, clause (a), para 2 (a) of this office circular dated 14-02-2019 *ibid*, their pensioners/family pensioners may submit a signed statement mentioning the name of the pensioner, date of joining of Government service and date of retirement, for compilation of database. The pensioners/family pensioners may also furnish details of department and place of last posting, post held at the time of retirement/death, date of death of the pensioner (if it is family pension) and name of the family pensioner (if family pension).

It is, therefore, requested to submit at an early date the signed statement mentioned above, to this office e-mail I.D. : [edppen-agae-wb@nic.in.](mailto:edppen-agae-wb@nic.in), in respect of Nagaland Government pensioners/family pensioners who are unable to furnish the prescribed documents mentioned in this office circular dated 14-02-2019 above, for onward transmission of the same to the o/o the Accountant General (A&E), Nagaland for taking necessary action from their end.
