Subject: Grant of Dearness Relief to the Maharashtra Government pensioners/family pensioners with effect from 01-01-2019 (payable in cash from 01-07-2019).

In continuation to this office circular No. Pen. Co-ordn./Maharashtra/Vol.-VII/Revision/28 dated 10-05-2019, this is to state that the Government of Maharashtra in their Finance Department Resolution No. DRP-2019/CR.313/SER-4 dated 15-07-2019 has sanctioned dearness relief to their pensioners/family pensioners as under:

Date of effect	Rate of Dearness Relief per month
01-01-2019	12% of basic pension/family pension

Dearness relief will @ 12% be paid in cash with effect from 01-07-2019. The orders regarding payment of arrears with effect from 01-01-2019 to 30-06-2019 will be issued on receipt of authority in this regard from the Accountant General (A&E) - I, Maharashtra.

2) The above rates of dearness relief would *mutatis mutandis* apply to those pensioners/family pensioners of Recognised and Aided Educational Institutions, Non-Agricultural Universities and Affiliated Non-Government Colleges and Agricultural Universities to whom the pension scheme is made applicable.

3) The above rates will also be applicable to the pensioners/family pensioners of Zilla

Parishads.

4) Maharashtra Government pensioners who had drawn lump sum payment on absorption in a PSUs/Autonomous bodies/Local Bodies and have become entitled to restoration of 1/3rd commuted portion of pension, will also be paid the increase in dearness relief at the prescribed rate and date mentioned in para 1 above. According to Government Resolution, Finance Department, No. COP-1001/50/SER-4, dated 9th April 2001, dearness relief will be paid on full pension.

5) Payment of dearness relief involving fraction of a rupec shall be rounded off to the

next higher rupee.

6) Having been authorised by the Accountant General (A&E)-I, Maharashtra in their letter. P.A. I/Governmental/G.R.No. P/19/Govt/60904907/Maharashtra/Ch.5/OW No. 60860508 dated 29-11-2019, it is requested to make necessary arrangements for payment of dearness relief to all cligible Maharashtra Government pensioners/family pensioners @ 12% on their revised basic pension/family pension in cash with effect from 01-07-2019 following the instructions laid down above and after proper adjustment.

7) The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Maharashtra etc."
