Subject: Grant of Pongal Prize to the Tamil Nadu Government pensioners/family pensioners for the Pongal Festival 2019.

In continuation to this office circular No. Pen. Co-ordn./Tamil Nadu/Vol.VII/Pongal/81 dated 30-07-2018, this is to state that the Government of Tamil Nadu in their G.O. No. 6 dated 08-01-2019 has sanctioned a lump sum Pongal Prize amount of ₹500/- (Rupees five hundred) only to all their pensioners who retired from the categories of 'C' and 'D' Group including all 'C' and 'D' Group of pensioners of Aided Educational Institutions, Local Bodies, Ex-Village Establishment (Ex-Village Officers and Village Servants/Assistants), ad-hoc pensioners of all categories and to all family pensioners irrespective of the Groups from which the pensioners/deceased Government employees had retired/died while in service, for the Pongal Festival, 2019.

- 2. This order shall also be applicable to all 'C' and 'D' Group provisional pensioners.
- 3. The Pongal Prize amount will not be admissible to the following categories of pensioners/family pensioners:
 - i) those employees who retired on or after 08-01-2019 and to the families of those employees who died in harness on or after 08-01-2019.
 - ii) those who have retired/died in harness during the period from 01-10-2017 to 07-01-2019 if they are paid adhoc bonus. For this purpose, the pension disbursing officers shall obtain non-drawal certificates from the departments concerned before making payment to these pensioners.
 - iii) special pensioners such as Ulema pensioners, Tamil Nadu State Freedom Fighter pensioners and Social Pension for Scholars and Eminent persons etc.
 - iv) family pensioners who are appointed on compassionate grounds if adhoc bonus/special adhoc bonus is paid to them as applicable to the employees in service.
 - v) All pensioners who retired from Group 'A' and 'B' posts including All India Service Officers and Officers governed by University Grants Commission (UGC)/All India Council for Technical Education (AICTE)/Indian Council of Agricultural Research (ICAR) Regulations.
- 4. Having been authorized by the Accountant General (A&E), Tamil Nadu in their letter No. AG/Pen-29/V/Pt 39717/UGC G.O.145 & PONGSL PRIZE/2018-19/122542 dated 03-04-2019, it is requested to make necessary arrangement for payment of Pongal Prize to all eligible Tamil Nadu Government pensioners/family pensioners keeping in view the instructions laid down above.
