*Subject : Restoration of commuted portion of pension in respect of Rajasthan Government pensioners, with effect from 01-10-1996.*

In continuation to this office circular No. Pen.VI/Rajasthan/Resto-Comm/9351 dated 16-01-1984, this is to state that the Government of Rajasthan in their Rajasthan Civil Services (Commutation of Pension) Rules, 1996 and FD Notification No. F. 15(4) FD(Rules)/97 dated 02-08-2005 has issued the instructions for restoration of commuted value of pension (CVP) as under :

i) A pensioner who retired from Government service and commuted a part of his pension subject to a maximum of 1/3rd of his original pension under the Commutation of Pension Rules, and on the date of promulgation of these rules or thereafter has completed or will complete 14 years from the respective dates of commutation, the commuted portion shall be restored from the first of the month following the month in which the period of 14 years has elapsed from the date of such commutation and shall be allowed full pension which he would have drawn but for commuting of a portion of pension.

ii) In cases where period of 14 years of commutation is already over before the date of promulgation of these rules, the commuted portion shall be restored from the date of promulgation of these rules.

iii) Government employees who got themselves absorbed under Public Sector Undertaking/Autonomous Bodies and have received or opted to receive payment of lump sum amount under Rule 34 of Pension Rules, shall not be entitled to the benefits of sub rule (1) as they ceased to be Government pensioners.

iv) The concerned Treasury Officer/Pension Payment Officer shall indicate the date of restoration of commuted pension as per provisions contained in sub rule (1) at the time of commutation of pension in the both halves of Pension Payment Order in the following format –

"The amount of pension of ₹                      commuted on                      shall be restored from the first of the month following the month in which the period of 14 years will elapse, i.e. on provided that the pensioner himself is alive on that date."

iv) This has been come into force with effect from 01-10-1996.

2. Having been authorized by the Accountant General (A&E), Rajasthan in their letter No. Pension Authority/Raj/06-07/3276 dated 05-09-2006 and Pension Authority/West Bengal/18-19/4722 dated 07-03-2019, it is requested to act upon accordingly.
