*Subject : Grant of one time cash incentives to the Puducherry Government Freedom Fighter pensioners/family pensioners/dependents in lieu of clothes/gift coupons on account of Independence Day, Gandhi Jayanti Day and De Jure Transfer Day Celebration 2019.*

This is to state that the Government of Puducherry in their G O Ms. No. 1/FFC/2019 dated 24-09-2019 have sanctioned cash incentives to the Freedom Fighters/family/dependents of Freedom Fighters in lieu of clothes/gift coupons to honour the Freedom Fighters on account of Independence Day, Gandhi Jayanti Day and De Jure Transfer Day Celebration 2019 along with the pension/family pension, as one time settlement, as under:

Puducherry State Freedom Fighter Pensioners	₹3500/-
Family/Dependents of Puducherry State Freedom Fighters	₹2500/-

Such pensioners/family pensioners drawing two pensions—one each for self and another for family/dependent pensioners are entitled for one payment only of ₹3500/-.

Having been authorised by the Directorate of Accounts and Treasuries, Puducherry in their letter No. 25596/DAT/Pen./A4/FFP/Incentive/2019 dated 18-11-2019, it is requested to make necessary arrangement for payment of one time cash incentives to the Freedom Fighters and to the family/dependents of Puducherry Government Freedom Fighters at the rate mentioned above as one time settlement.
