Their appointment as AAO (Ad-hoc) will be subject to the following conditions:

- They will not be given any supervisory responsibilities. They will continue to discharge the same functions and duties as discharged by them while holding the current post. However, they may be given task of more arduous nature involving greater analytical skills and may be assigned workload that is substantially higher than existing norms for their present post.
- The service rendered by them as AAO (Ad-hoc) will not be counted as regular service in AAO cadre for the purpose of seniority, promotion, eligibility for appearing in Departmental Examination (i.e. incentive examination/CPD examination etc.) or for any other entitlement.
- Appointment on Ad-hoc basis is purely a stop-gap arrangement and such Ad-hoc appointment can be reviewed and if circumstances so warrant, they may be reverted to their substantive post.

They may exercise the option for choosing the date of fixation of pay under FR-22 (I) (a) (I) on appointment to the post of Asstt. Accounts Officer (Ad-hoc) in accordance with Government of India M/O Home Affairs, Department of personnel & Administrative Reforms O.M. NO. F, 7/1/80/- Estt. P.I. dated 26.09.1981 read with Resolution No. 01-2/2016-IC dated 25.07.2016 of GoI, Ministry of Finance (Department of Expenditure).

The option has to be exercised within one month from the date of joining as Asstt. Accounts Officer (Ad-hoc).

The option once exercised shall be final.
