Subject: Precautionary measure to contain the spread of COVID-19.

It has been reported that Sh. Pramod Kumar Kaushal, Sr. Accounts Officer of BOOK-II, Fund-7 & Fund-10 has been tested and found COVID-19 positive. He attended office yesterday (08.10.2020).

In view of the above, the following instructions are hereby issued:-

- 1. The officer is instructed to attend office physically only after testing negative.
- 2. Officers/officials who came in his direct contact as detailed in Annexure-I are instructed to work from home for a period of one week i.e. upto 18.10.2020 in terms of Hqrs' letter no. 181-Estates/11-2020 dated 02.07.2020. All officers/officials are instructed to monitor their health and inform their controlling officers about the same. The officers/officials may physically attend office after the above period only if they do not develop any symptoms of COVID-19. If the officers/officials report symptoms at the end of above period/during the period he/she may get tested for COVID and physically attend office only after testing negative.
- Welfare officer may ensure the 2<sup>nd</sup> floor of the Gorton castle building (New Portion) shall be disinfected as per Ministry of Health and Family Welfare guidelines.
- 4. The other officers/officials as per Annexure-II who were in indirect contact with Shri Pramod Kumar Kaushal, Sr. AO shall monitor their health closely. In case they develop any of the symptoms of COVID-19 as notified by the Ministry of Health, they shall go for COVID-19 testing and intimate the advice tendered by doctor and report development from time to time.

The above order shall be come into force immediately.
