OFFICE ORDER

As per Rule 15(1)(c) of CCS (Conduct) Rules, 1964, “ no Government servant shall except with the previous sanction of the Government hold an elective office, or canvass for a candidate or candidates for an elective office, in any body, whether incorporated or not.”

As per Sl. No.13, Section F of the CAG's Manual of Standing Order Volume-II, the power to grant such permission lies with the Comptroller & Auditor General of India.

Headquarters office has directed to ensure that proposals for sanction for contesting/holding elective office in Co-operative Societies complete in all aspects, along with recommendations of Head of Department should be forwarded to Hqrs. Office, at least one month before the scheduled date of elections, so as to enable Hqrs. Office to examine the proposal in detail before its submission for consideration of the Competent Authority.

Accordingly, all officials of this office who wish to contest for an elective post in elections of any body, whether incorporated or not and co-operative societies, or canvass for a candidate or candidates for an elective office in such bodies should submit their applications duly forwarded by their respective Branch Officers to the Sr. Dy. Accountant General (Admn.), atleast 40 days prior to the date of election in that body, so that the same can be processed in this office and forwarded to Hqs. Office, within the time frame specified.

Contd.

It is reiterated that no official should contest/hold elective office without the prior approval of the Competent Authority. Else it would be construed as a violation of the Conduct Rules.


