OFFICE ORDER

The Examination wing of Hqrs. Office has vide Circular No.05 of 2020, circulated vide No. 147/06-Exam/Prof. Qualification/2020, dated 21 July 2020 notified that, with a view to attract talent and promote knowledge enhancement, due recognition is given to certain professional qualifications acquired by the officials from recognized/reputed institutions such as The Institute of Chartered Accountants of India and The Institute of Cost Accountants of India. Accordingly, candidates having such professional qualification are exempt from appearing in some of the papers of the SAS Examination in terms of Note 2 & 3 below Para 9.2.10 of Chapter 9 of C&AG's MSO (Adman) Vol.-I.

Now, it has been decided by the competent authority to invite suggestions from officials of the department, regarding the professional qualifications that could be considered for grant of exemption in the papers of the departmental examinations viz. SAS/RA/I/CPD, depending on similarity of the syllabus/contents of the papers. The suggestions are to be submitted in the enclosed format.
