Subject: (i) Revision of pension/family pension and grant of dearness relief with effect from 01-01-2016 in respect of pre-2016 Odisha Government Medical College Teacher pensioners/family pensioners under UGC Scale of Pay; and

(ii) Clarification for payment of additional pension/family pension to the old pensioners/family pensioners with effect from 01-12-2008.

This is to state that the Government of Odisha in their OM No. HFW-MEI-PROF-0006-2019-33017 dated 16-12-2019 has revised pension/family pension with effect from 01-01-2016 to all their pre-2016 Government Medical College Teacher pensioners/family pensioners who were drawing pension/family pension on 31-12-2015 under the Odisha Civil Services (Pension) Rules, 1992 with UGC Scale of Pay.

- 2. The existing pension and family pension of all pre-2016 pensioners/family pensioners as on 01-01-2016 shall be revised by multiplying a factor of 2.57. The amount of revised pension/family pension so arrived at shall be rounded off to next higher rupee.
- 3. For this purpose the existing pension/family pension shall be the basic pension/family pension only without the element of additional pension available to the pensioners/family pensioners of the age of 80 years and above.

Provided that the revised full pension of all pre-2016 pensioners relatable to maximum period of qualifying service i.e. 25 years shall in no case be less than the 50% of the 1st Cell of the replacement level in pay matrix shown in enclosed Annexure-'A' with effect from 01-01-2016.

- 4. In case of pensioners who are in receipt of more than one pension, the floor ceiling of ₹8,300/- shall apply to the total of all pensions taken together.
- 5. The basic pension/family pension as worked out in accordance with the provisions of para 2 above shall be treated as final basic pension with effect from 01-01-2016 for the purpose of sanction of dearness relief to be sanctioned thereafter.
- 6. The revised family pension of all pre-2016 family pensioners shall not be less than 30% of the 1st Cell of the replacement level in pay matrix of the scale of pay of the post last held by the pensioner at the time of his retirement/death shown in enclosed Annexure-'A' with effect from 01-01-2016.
- 7. Since the basic pension shall be inclusive of commuted portion of pension, the commuted portion if availed by the pensioner shall be deducted from the said amount while making monthly disbursements. Besides, the ex-gratia relief granted in FD OM No. 56932/F. dated 28-11-1986 shall also be paid in addition to the consolidated pension in respect of eligible pensioners.
- 8. The minimum pension/family pension in no case shall be less than ₹8,300/- per month with effect from 01-01-2016. The upper ceiling on pension and family pension shall be 50% and 30% respectively of the highest pay in the Government under UGC scale. The minimum and the maximum limit shall exclude the element of additional pension.
- 9. The quantum of additional pension/family pension available to the pensioners/family pensioners shall be revised to the percentage of basic pension/family pension as per the table below with effect from 01-01-2016.

Age of pensioners/family pensioners

From 80 years to less than 85 years
(completion of 80 years)
From 85 years to less than 90 years
(completion of 85 years)
From 90 years to less than 95 years
(completion of 90 years)
From 95 years to less than 100 years
(completion of 95 years)
100 years or more
(completion of 100 years)

Additional quantum of pension/family pension 20% of revised basic pension/family pension 30% of revised basic pension/family pension 40% of revised basic pension/family pension 50% of revised basic pension/family pension 100% of revised basic pension/family pension

10. The pension/family pension as revised above shall qualify for dearness relief sanctioned by the Government of Odisha and circulars issued by this office from time to time. However, the rate and date of effect of dearness relief is mentioned below:

01-01-2019	12 /0 Of Dasie Pension

It is also decided that dearness relief (TI) at the rates indicated in the above table shall also be admissible on the additional basic pension/additional family pension available to older pensioners/family pensioners based on their age.

- 11. Payment of dearness relief (TI) involving fraction of a rupee shall be rounded off to the next higher rupee.
- 12. The pre-2016 pensioners/family pensioners shall submit an application to the Accountant General (A&E), Odisha/Controller of Accounts, Odisha, Bhubaneswar through the concerned pension disbursing authorities including Public Sector Banks for revision of pension/family pension in the form as at Annexure 'B' enclosed.
- 13. The fact of authorization of the revised rate of pension/family pension shall be recorded in both halves of Pension Payment Order (PPO) under the dated signature of the authorised officer of the concerned Treasuries/Public Sector Banks. Pension Disbursing Authorities shall intimate the Accountant General (A&E), Odisha, Bhubaneswar 751 001 as well as to this office in the enclosed proforma (Annexure-C) about such revision for necessary correction in the Pension Payment Order register maintained in those offices.
- 14. Besides, in continuation to this office circular No. Pen. Co-ordn./Orissa/Vol.-VI/DR/180 dated 11-03-2010, this is to state that the Government of Odisha in their FD OM No. 40423/F dated 03-12-2019 has decided that Aadhar Card will be accepted as proof of date of birth or age for payment of additional pension/family pension on completion of 80 years and above where the date of birth or age of the old pensioner is not available in Pension Payment Order, in addition to the documents mentioned in the circular dated 11-03-2010 ibid.
- 15. Having been authorized by the Principal Accountant General (A&E), Odisha in their letter No. P.M.-1-10-1-State/Odisha/SSA/2019-20/329(34) dated 02-01-2020, it is requested to display this circular to the notice boards of all pension disbursing authorities so that the concerned pensioners/family pensioners can apply for revision of their pension/family pension as per instructions laid down above. It is also requested to accept Aadhar Card as proof of date of birth or age for payment of additional pension/family pension on completion of 80 years and above where the date of birth or age of the old pensioner is not available in Pension Payment Order, in addition to the documents mentioned in the circular dated 11-03-2010 ibid
- 16. These orders are applicable only for aforesaid category of Odisha Government pensioners/family pensioners retired/died in harness on or before 31-12-2015. Such category of pensioners/family pensioners who retired/died in harness on or after 01-01-2016 may apply to their respective pension sanctioning authorities for getting their pension/family pension revised. In their cases separate individual authorities will be issued from this office on receipt of authorities in these regards from the Principal Accountant General (A&E), Odisha.
- 17. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Odisha etc."
