- 2. Besides, in continuation to para 9 of this office circular No. Pen. Co-ordn./Tamil Nadu/Vol.VII/Revision/208 dated 21-03-2018, this is to state that the Government of Tamil Nadu in their G.O. Ms. No. 277 dated 29-08-2019 has decided that the 2/3rd portion of commuted pension in respect of Tamil Nadu Government pensioners who had been absorbed in TANSI and were drawing one third of pension/family pension with effect from 04-05-1991 to 30-09-2017 shall be calculated, and to pay arrears of such 2/3rd pension to these Absorbee pensioners/family pensioners and their legal heirs in the case of Absorbee pensioners/family pensioners who have expired. No interest shall be paid on the arrears of such 2/3rd portion of commuted pension.
- 3. Absorbee pensioner/family pensioner shall apply to the pension disbursing authority concerned in the prescribed form as at Annexure appended to this circular. In case of Absorbee pensioners/family pensioners who have expired, the arrears shall be paid to their legal heirs on their claim. For this purpose, the legal heir shall apply along with death certificate and relevant documents.

Having been authorized by the Accountant General (A&E), Tamil Nadu in their letter No. AG(A&E)/P29/V/Pt.42152,42617,43525/2019-20/74553 74618/74602 dated 06-01-2020, it is requested to display this circular on the notice board to inform the concerned pensioners. It is also requested to make necessary arrangement for payment of 2/3rd portion of commuted pension along with arrears in respect of Absorbee pensioners of Government of Tamil Nadu, who were drawing one third of pension/family pension with effect from 04-05-1991 to 30-09-2017 to the Absorbee pensioner/family pensioner and legal heir(s) in the case of death of Absorbee pensioner/family pensioner within a month, observing the instructions laid down at para 2 and 3 above.
