Subject : Grant of Dearness Relief to the Himachal Pradesh Government pensioners/family pensioners with effect from 01-01-2019 and 01-07-2019.

In continuation to this office circular No. Pen. Co-ordn./H P/Vol.- VI/DR/32 dated 21-05-2019, this is to state that the Government of Himachal Pradesh in their OM Nos. Fin (Pen) B (10)-6/98-IV dated 21-08-2019 and Fin (Pen) B (10)-6/98-IV dated 07-03-2020 have sanctioned dearness relief to their pensioners/family pensioners at the rate and from the date as under :

Date of effect	Rate of dearness relief per month
01-01-2019	148% of basic pension/family pension
01-07-2019	153% of basic pension/family pension

2. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. Other provisions governing grant of dearness relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.

4. Having been authorized by the Accountant General (A&E), Himachal Pradesh in their letter Nos. Pension-1/Pension Special Cell/Himachal Pradesh Shimla/2019-20/1072 – 1104 dated 14-10-2019 and Pension-1/Pension Special Cell/Himachal Pradesh Shimla/2020-21/215 – 48 dated 15-06-2020, it is requested to make necessary arrangement for payment of dearness relief to all eligible Himachal Pradesh Government pensioners/family pensioners @ 148% and 153% on their basic pension/family pension with effect from 01-01-2019 and 01-07-2019 respectively after proper adjustment.

5. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Himachal Pradesh etc."
