Subject: Grant of Dearness Relief to the Haryana Government pensioners/family pensioners on their un-revised pension/family pension with effect from 01-07-2016, 01-01-2017, 01-07-2018, 01-07-2018 and 01-01-2019.

In continuation to this office circular No. Pen. Co-ordn./Haryana/Vol.- VII/DR/58 dated 05-07-2016, this is to state that the Government of Haryana in their OM No. 4/1/2017-2FR/34518 dated 23-01-2018 and 4/1/2017-2FR/3462 dated 23-07-2019 have sanctioned dearness relief on revised pension/family pension of their pensioners/family pensioners as under:

| Date of effect | Rate of dearness relief per month    |
|----------------|--------------------------------------|
| 01-07-2016     | 132% of basic pension/family pension |
| 01-01-2017     | 136% of basic pension/family pension |
| 01-07-2017     | 139% of basic pension/family pension |
| 01-01-2018     | 142% of basic pension/family pension |
| 01-07-2018     | 148% of basic pension/family pension |
| 01-01-2019     | 154% of basic pension/family pension |

- 2. These orders will not apply to the pensioners whose pension has been determined on adhoc basis without reference to the emoluments drawn by them, i.e. Political Pension, Special Pension, War Risk Pension etc.
- 3. Other provisions governing grant of dearness relief to pensioners such as regulation of dearness relief during the period of employment/re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.
- 4. Payment of dearness relief involving a fraction of rupee shall be rounded off to the next higher rupee if the same is 50 paise or above. Conversely, it will be rounded off to the lower side if the same is less than 50 paise.
- 5. Having been authorised by the Accountant General (A&E), Haryana in their letter Nos. Pen-1/Gen-26/Grant of Dearness Relief/2019-20/2843 2932 dated 28-11-2019 and Pen-1/4/Gen-26/20-21/367 dated 11-08-2020, it is requested to make necessary arrangement for payment of dearness relief to all eligible Haryana Government pensioners/family pensioners @ 132%, 136%, 139%, 142%, 148% and 154% on their basic pension/family pension with effect from 01-07-2016, 01-01-2017, 01-07-2017, 01-01-2018, 01-07-2018 and 01-01-2019 respectively after proper adjustment.
- 6. The charges on this accounts are debitable to the head "8793-I.S.S.A/cs.; Government of Haryana etc."
