**CIRCULAR**

In pursuance of Headquarters Examination wing's letter No. 448/0/-Exam/Cadre Re-structuring/2020 dated 13-11-2020, the centralized training evaluation examination of eligible Senior Accountants for promotion as Assistant Supervisor will be held on 19-12-2020 (Saturday) from 11.00 am to 01.00 pm.

The examination consist of two parts – Accounts work (50% marks) and General Administrative work (50% marks). There will be 100 questions of MCQ type and will be in pen paper based mode. The qualifying marks will be 40% with no negative marking.

The examination will be conducted in the Canteen Hall, L&R Club Hall opposite canteen and in the A&E Training Hall opposite CGHS dispensary in the ground floor of this Office. The candidates should report to the exam venue along with Office Identity Cards, 15 minutes before the examination time i.e. 10.45 A.M positively. All candidates should fully co-operate with Administration in the conduct of examination and ensure adherence to Covid preventive measures.
