**Subject: Exercise of option for regular pay fixation benefit at the time of promotion to the post of Senior Divisional Accounts Officer after availing benefit under NFU.**

As approved by the competent authority, it is clarified that the employees who have been granted NFU in Level-9 on or after 01.01.2016 shall be eligible for regular Pay fixation benefit on his further promotion to the post of Senior Divisional Accounts Officer (Sr. DAO) in Level-10 of 7<sup>th</sup> CPC Pay Matrix as per extant provisions.

An option shall be exercised to this effect to the D.D.Os of the division by the serving Sr. DAOs and to the undersigned by the retired Sr. DAOs. Option shall be exercised within one month from the date of issue of this circular.

For the serving Sr. DAOs, after necessary pay fixation in the division, the case may be sent to this office for ratification.

Revision of pay in respect of retired Sr. DAO will be initiated from this office on the basis of option exercised by the incumbent.

It is circulated for information and necessary action for all concerned in respect of all such Sr. DAO (Level-10) posted in/ retired from different Divisions in West Bengal.
