## OFFICE ORDER

All officers/ officials under Divisional Accountant Cadre including those who are on deputation from other offices are requested to submit the Annual Property Return for the year ending 2020 (as on 31.12.2020) in the prescribed proforma giving full particulars of immovable properties inherited / owned / acquired by him/her or held by him/her on lease or mortgage either in his /her own name or in the name of any member of his/ her family or in the name of any other person. The officers/ officials who are on deputation in the cadre from this office are requested to submit their Annual Property Return in the official website of this office (http://cag.gov.in/ae/west-bengal/en) through Employee Login under the field "My Application & Declaration). All detailed particulars are required to be indicated in the return. The terms like "No change" or "No addition" or "Same as before" will not be accepted.

In terms of Rule 18, GID (31) of CCS (Conduct) Rules, failure to submit the Annual Property Return by 31<sup>st</sup> January 2021 shall entail denial of vigilance clearance and the persons concerned shall not be considered for empanelment for senior level posts in Government.

Accordingly, all the officers/ officials under Divisional Accountant Cadre including those who are on deputation from this office and other offices are requested to submit the immovable property statements for the year 2020 in the prescribed proforma (copy enclosed) and in above mentioned procedure latest by 31 January, 2021 positively failing which appropriate action will be taken.
