As they are entitled to have their pay fixed under FR 22 (I) (a) (1), they have to exercise an option within one month from the date of issue of this order for fixation of their pay either on the date of effect of MACPS or on the date of accrual of next increment. Option once exercised shall be final. There shall, however, be no further fixation of pay at the time of regular promotion. The financial upgradation under the Modified Assured Career Progression Scheme shall be purely personal to the employee and shall have no relevance to the seniority position. As such, there shall be no additional financial upgradation for the senior employees on the ground that junior employee in the grade has got higher Pay/ Grade Pay under the MACPS.
