In continuation to this office circular No. Pen. Co-ordn./Rajasthan/Vol.-VI/FF/172 dated 06-11-2012, this is to state that the Government of Rajasthan in their General Administration (Group-6) Department Order No. P. 4(4)GA/6/2008 dated 01-04-2013 has enhanced the existing Freedom Fighters Samman Pension/Dependent pension from ₹17,000/only per month to ₹20,000/- (Rupees Twenty thousand) only per month and existing Medical Assistance from ₹3,000/- to ₹4,000/- (Rupees Four thousand) only per month to such pensioners, i.e. total ₹24,000/- (Pension ₹20,000/- + Medical Assistance ₹4,000/-) only per month with effect from 01-04-2013.

Pension Authority/State/F.F./Guard File/2019-20/6800 dated 12-03-2020 and Pension Authority/State/F.F./Guard File/2020-2/1762 dated 05-10-2020, it is requested to make necessary arrangement for payment of enhanced rate of Freedom Fighters Pension to the Rajasthan Government Freedom Fighters and their dependents @ ₹24,000/- (Rupees Twenty four thousand) only per month with effect from 01-04-2013 and @ ₹30,000/- (Rupees Thirty thousand) only per month with effect from 20-02-2019 after proper adjustment.
