Subject: Revision of pension/family pension with effect from 01-01-2006 in respect of pre-01-01-2006 Judicial Officers of Chhattisgarh Judicial Service.

This is to state that the Government of Chhattisgarh in their Notification Nos. 12082/2827/21-B/C. G./2010 dated 03-11-2010 and 2583/520/XXI-B/C.G./19 dated 08-03-2019 have revised, with effect from 01-01-2006, pension/family pension of the Chhattisgarh Government Judicial Officers who retired/died in harness prior to 01-01-2006 as per recommendations of Justice Padmanabhan Committee and as accepted by the Hon'ble Supreme Court of India.

2. The revised pension of the retired Judicial Officers should be 50% of the minimum pay of the revised pay scale of the post held by him at the time of the retirement, shown in the table below:

Provided that at the time of revision and re-fixation, the existing pension shall be consolidated first as follows:

- i) Existing pension as on 01-01-2006
- ii) Dearness Pension as on 01-01-2006
- Dearness relief at prevalent rate on both the existing basic pension and Dearness Pension as on 01-01-2006

Provided further that the Judicial Officers, who have ceased to be in service due to death or retirement after 01-11-2000 and prior to 01-01-2006, there pension, which has been revised in accordance with the said rules, shall be revised by raising the same by 03.07 times with effect from 01-01-2006 which shall not be less than 50% of the revised pay of revised pay scale equivalent to the last pay drawn at the time of his retirement.

3. The revised pension shall be fixed at minimum 50% of the revised pay as mentioned in para 2 or consolidated pension as calculated above, whichever is higher, provided that such Judicial Officer who retired after 01-11-2000 and prior to 01-01-2006 and whose pension has been revised in accordance with the said rules, the full family pension in respect of the family pensioners shall be revised by raising the same by 03.07 times with effect from 01-01-2006 which shall not be less that 30% of the pay of revised pay scale equivalent to the last pay drawn by the Judicial Officer at the time of retirement.

4. There should not be any ceiling limit on the pension.

5. The dearness relief shall be at the rates as are applicable to the serving Judicial

6. The retired Judicial Officers/family pensioner are entitled for payment of

additional quantum of pension/family pension as under:

Age of pensioner/family pensioner	Additional quantum of pension	
From 80 years to less than 85 years	20% of revised basic pension/family pension	
From 85 years to less than 90 years	30% of revised basic pension/family pension	
From 90 years to less than 95 years	40% of revised basic pension/family pension	
From 95 years to less than 100 years	50% of revised basic pension/family pension	
100 years or more	100% of revised basic pension/family pension	

7. Having been authorized by the Accountant General (A&E), Chhattisgarh in their letter Nos. P.A./General/Relief Order/435 dated 14-05-2019 and P.A./R-2/3486 dated 13-04-2020, it is requested to make necessary arrangement for payment of revised rate of pension/family pension and dearness relief with effect from 01-01-2006 to the aforesaid pensioners/family pensioners as per guideline laid down above and after proper adjustment.

8. The charges on this accounts are debitable to the head "8793-I.S.S. A/cs.; Government of Chhattisgarh etc."
