Sir/Madam,

It is intimated that Ministry of Finance has accorded its approval for grant of level 9 on non-functional basis to the post of Supervisor, on completion of 04 years of regular service in level 8 w.e.f 01.01.2016, as in the case of Asstt. Accounts/Audit Officers in IA &AD.

- 2. Grant of NFU to Supervisors w.e.f 01.01.2016 will be under following terms and conditions:
 - (i) The grant of Non-Functional Upgradation (NFU) in Pay Level 9 shall be admissible to the Supervisors of IA & AD on completion of 4 years of regular service in the cadre from the date of joining as Supervisor in level 8. The aforesaid non-functional upgradation (NFU) to Supervisors is effective from 01.01.2016.
 - (ii) The benefit of pay fixation admissible as per Rule 13 of CCS Revised Pay Rules, 2016 shall be available at the time of grant of non-functional upgradation.
 - (iii) NFU will be subject to vigilance clearance. While issuing orders, it may be ensured that none of the circumstances for adoption of sealed cover procedure exists and the official is not undergoing any penalty under CCS (CCA) Rules, 1965.
 - (iv) NFU will be reckoned for financial upgradation under Modified Assured Career Progression Scheme (MACPS). Subsequent financial upgradation under MACPS, if any, is to be reckoned from the date of grant of NFU.

- 3. The orders for grant of non-functional upgradation to Supervisors shall be issued by the respective Appointing Authority. No approval of Hqrs. Office is required for grant of NFU to the eligible Supervisors.
- 4. Due to re-fixation of pay, subsequent to grant of NFU, arrears of pay and allowances may be paid to the officials, as admissible under 7th CPC.
