Subject: Revision of pension/family pension and grant of dearness relief in respect of pre-01-01-2016 Kerala Government pensioners/family pensioners coming under UGC Scheme, notionally with effect from 01-01-2016 and with monetary benefit from 01-11-2020.

Date: 03-03-2021

This is to state that the Government of Kerala in their G O (P) Nos. 151/2020/Fin dated 05-11-2020 and 157/2020/Fin dated 19-11-2020 has revised pension/family pension and related benefits in respect of their pre-01-01-2016 pensioners/family pensioners coming under UGC Scheme, notionally with effect from 01-01-2016 and with monetary benefits from 01-11-2020 (i.e. pre-revised rate of pension shall continue till 31-10-2020).

2. These orders are not applicable to the teachers coming under AICTE, Medical Education, Ayurveda, Homeo. Circular for revision of pension/family pension in respect of those pensioners will be issued separately on receipt of special seal authority in this regard from the Principal Accountant General (A&E), Kerala.

3. Pension may be revised in accordance with the principle laid down as under:

Revised Basic Pension = Existing basic pension as on 31-12-2015 x 2.57 (rounded to next rupees) plus personal allowance, if any (protected during 01-01-2006 UGC revision), subject to the condition that the pension so arrived is not less than 50% of Entry Level Pay mentioned as Academic Level Pay in Schedule I attached to this circular, for those eligible for full pension, and prorated to Qualifying Service to those having less than 30 years of service. Maximum of revised basic pension shall not exceed ₹60000/-, i.e. the maximum pension admissible as per existing Kerala State Pension Revision Orders.

4. Family pension may be revised in accordance with the principle laid down as under:

Revised Basic Family Pension = Existing basic family pension as on 31-12-2015 x 2.57 (rounded to next rupees) plus personal allowance, if any (protected during 01-01-2006 UGC revision), subject to the condition that the revised basic pension so arrived is not less than 30% of Entry Level Pay mentioned as Academic Level Pay in Schedule I attached to this circular. The revised basic family pension shall not exceed ₹60000/- in the case of those drawing Higher Rate and ₹36000/- for those drawing Normal Rate.

5. If any drop in gross pension/family pension occurs while revising pension/family pension, i.e. if revised pension + 9% DR admissible at revised rates is found less than the prerevised pension + 148% DR on pension as on 01-11-2020, the difference shall be protected as personal allowance from time to time till the drop vanishes, as illustrated in Schedule II attached to this circular subject to the clarification issued vide sub para (c) of para 2 of the erratum dated 19-11-2020 ibid.

6. Dearness relief shall be payable at revised Central rates i.e. 9% from 01-11-2020. The dearness relief on the revised basic pension/family pension shall be at the rate sanctioned to the employees coming under UGC scheme by the Government of Kerala from time to time. The rate of dearness relief on revised pension/family pension as sanctioned will be as under:

Dearness relief is not payable on personal allowance.

7. The revised scale of pay corresponding to the pre-revised scale admissible and method

of revision of pension are shown in Schedule I and II annexed to this circular.

8. The monetary benefit of revision of pension shall be given only with effect from 01-11-2020. Circular for disbursement of arrears from 01-01-2016 to 31-10-2020 will be issued on receipt of special seal authority in this regard from the Principal Accountant General (A&E), Kerala.

- 9. In the case of pensioners whose pension transferred to other States, they shall submit their application to their respective Pension Disbursing Authorities (Treasury/Bank) for revising the pension.
- 10. Having been authorized by the office of the Principal Accountant General (A&E), Kerala in their letter No. PM/2/6-150/UGC REVISION/2020-21/5 dated 25-11-2020, it is requested to make necessary arrangement for revision of pension/family pension in respect of Kerala Government pensioners/family pensioners of aforesaid categories as per instructions laid down above and after proper adjustment. A copy of the circular may also be displayed on the notice board for the information of the concerned pensioners.

11. This order shall not be applicable to post-01-01-2016 pensioners/family pensioners of the Government of Kerala. In their cases separate individual authorities will be issued from this office on receipt of the same from the Principal Accountant General (A&E), Kerala.

12. The charges on this account should be debitable to the head "8793-I.S.S. A/cs.; Govt. of Kerala etc."
