

(2) The benefit of pay fixation admissible as per Rule 13 of CCS Revised Pay Rules, 2016 will be available at the time of grant of non-functional upgradation.

(3) The provisions of F.R. 22 regarding regulation of pay fixation in the cases of two promotions in quick succession are to be followed, i.e., the pay of the Government servant, who in the event of first promotion has opted to get his pay fixed in terms of the saving clause but before the re-fixation of pay from the date of increment in the lower post, gets another promotion, will be fixed with reference to the pay admissible on the date of second promotion and such Government servant is not entitled to re-fixation of pay for the first promotion from the date of next increment.

(4) NFU granted to the above officials will be reckoned for financial upgradation under Modified Assured Career Progression Scheme (MACPS). Subsequent financial upgradation under MACPS, if any, is to be reckoned from the date of grant of NFU.

Due to re-fixation of pay, subsequent to grant of NFU, arrears of pay and allowances may be paid to the officials, as admissible under 7th CPC.


