## CIRCULAR

Sub: Recall of field audit teams in view of restrictions imposed by Government of Odisha.

Government of Odisha, General Administration & Public Grievance Department vide Order No. GAD-COOD-MISC-0001-2018-11465/Gen dated 15.04.2021 has decided that all Departments of the Government shall function with 50% of the staff strength (except officers of the rank of Deputy Secretary and above who shall attend office daily) with effect from 19.04.2021. In NACs/Municipalities of 10 border Districts adjacent to Chhattisgarh and Jharkhand, there will be night curfew from 6.00 PM to 5.00 AM and weekend shutdown. In the remaining 20 Districts, there will be night curfew from 9.00 PM to 5.00 AM.

In view of the above, the competent authority has directed that all the field audit teams may be recalled to Headquarters from 16.04.2021 (AN). AMGs may continue with tour programmes which do not involve overnight stay outside Bhubaneswar, subject to the concurrence of the audited units. The Office shall continue to function with 50% of staff strength as per circular dated 15.04.2021. All field audit teams which do not have active tour programmes should work from home, as per the assignments allotted during the month of April 2021. All Officers/ staff are requested to be available on telephone and electronic means of communications.
