## **OFFICE ORDER**

The Government of Rajasthan vide their order dated 30-04-2021 had declared "**Epidemic-Red Alert** – **Jan Anushasan Pakhwada**" in the State from 03 May (05:00 AM) to 17 May 2021 (05:00 AM) for effective control and to contain the spread of novel coronavirus (COVID-19) and this office had also issued order on 01-05-2021 in pursuance to these orders. Now due to increasing case of COVID-19 in rural area as well as in youth, the State Government vide their order dated 06-05-2021 issued additional instructions for lockdown from 10 May 2021 (05:00 AM) to 24 May 2021 (05:00 AM). In order to cooperate with State Government orders, following instructions are issued in continuation of this office order 01-05-2021:-

- 1. O/o the Accountant General (Audit-I), Rajasthan, Jaipur,O/o the Accountant General (Audit-II), Rajasthan, Jaipur, and O/o the Pr. Director of Audit (Central), Branch Office, Rajasthan, Jaipur would run with skeletal staff who will attend office on specific requirement up to 23 May 2021 and field audit will remain postponed till then. Remaining all officers and officials are directed to work from home till 23 May 2021.
- 2. Permission to leave headquarter would not be allowed except in special circumstances/ emergency situation assessed and permitted by Group Officer of concerned wing.
- 3. All employees are advised to get themselves vaccinated including family members who have attained the age of 18 years and above so as to effectively contain the spread of COVID-19. They are further advised to continue to follow covid appropriate behavior, even after vaccination, particularly, frequent washing of hands/sanitization, maintenance of social distancing and putting on of mask etc.
- 4. All other instructions issued vide office order dated 01-05-2021 would remain in existence for strict compliance.
