**Subject: Revision of rates of honorarium for In-house training-reg.**

Sir/Madam,

I am directed to invite a reference to this office Circular No. 32-Staff Entt.II/2018 issued under letter No. 143-Staff Entt.II/25-2018(I) dated 12.10.2018 regarding revision of rates of honorarium payable to faculty and to state that the rates of honorarium for delivering lectures at in-house training in field offices have now been revised as per the details given below:

Sl. No.	Faculty Type	Existing Rates	Revised Rates
1	Serving Officers	250	500
2	Non-Serving Officers	250	1000
3	Experts/Eminent Persons	400	2000 per session

2. The above rates are applicable subject to the following conditions:
  - (i) All field offices may not exceed the budget allocated to them,
  - (ii) Maximum honorarium payable to in-service faculty is subject to ceiling, of upto 30 days or 60 sessions in a year, whichever is lower.
  - (iii) Honorarium payable to expert/eminent faculty may be limited to Rs. 2,000/- per session,
  - (iv) No exceptions to the above will be allowed.
3. The revised rates of honorarium will be effective from 01.04.2021.
