**OFFICE ORDER -11**

In pursuance of Orders of Administration vide Order No. HRM-I/COVID-19/105 dated 26-06-2021, and pursuant to Government of Maharashtra Order No. DMU/202/CR-9/Dism-1, dated 25/06/2021 and Nagpur Municipal Corporation Order No.56/COVID-19/2021 dated 26/06/2021 the roster of Accounts Wing for attendance of officials in the office is revised as follows. This revised roster shall be effective immediately. It shall remain into effect till further orders. All other instructions related to prevention of Coronavirus Pandemic, as issued from time to time shall continue to be observed. The following orders are issued with immediate effect.

- 1 These orders shall function with only 50% of total staff strength w.e.f. 28/06/2021 until further orders..
- 2 All Sr. Accounts Officers, shall attend the office every day.
- 3 The accounts wing shall function as per the roster enclosed as Annexure
- 4 Use of 'Arogyasetu' App is mandatory for all employees. All Officers, staff (including outsourced staff) should download 'Arogyasetu' App on their mobile phones
- 5 Before starting for office, they must review their status on 'Arogyasetu' and commute only when app shows 'safe' or 'low risk' status.
- 6 The officer/staff are advised that in case the App shows a message that he/she has 'moderate' or 'high risk' calculated on the basis of Bluetooth proximity ("recent contact with infected person"), he/she should not come to office and self-isolate for 14 days'
- 7 Social distancing norms may be strictly observed by all in the open space like lawn, parking area, corridor, etc. Moving around in the groups should be strictly avoided. Flouting of this directives, may invite disciplinary action.
