**Office Order**

Following the recommendation made by the Departmental Screening Committee in the light of Headquarters' Circular No. 42-Staff Wing-2020 issued vide letter No. 1027-Staff (Entt.I)/78-2020 dated 15.10.2020, the Competent Authority is pleased to accord the sanction of 2<sup>nd</sup> financial upgradation under MACP Scheme from Pay Level 10 to 11 w.e.f. 04.06.2021 in respect of Shri Niranjan Prasad, Sr. Accounts Officer treating his service as direct recruitment from the date of his appointment to the post of AAO (erstwhile post of SO) in terms of provisions contained in Headquarters' Circular No. 23-Staff Wing/2016 issued vide letter No. 39-Staff (Entt. I)/184 dated 20.06.2016 and Circular No. 10-Staff Wing/2017 issued vide letter No. 346-Staff (Entt-I)/58-2016 dated 09.02.2017 read with DoPT's O.M. No. 35034/3/2008-Estt (D) dated 19.05.2009 and O.M. No. 35034/3/2015-Estt. (D) dated 22.10.2019.

Benefit of pay fixation shall also be allowed at the time of financial upgradation under the scheme. Therefore, the pay shall be fixed in the next pay level after raising the pay by one index point in the pay level drawn before such upgradation. There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same pay level as granted under MACP scheme.

Option regarding fixation of pay under FR 22(1) (a) (i) shall be exercised within one month from the date of issue of the office order. Option once exercised shall be final.

The financial upgradation allowed under this scheme shall be purely personal to the employee and shall have no relevance to his seniority position.
