2. The period of deputation shall be for one year initially which may be extended as per norms or till the notifications of Model Recruitment Rules (RRs) for the post, whichever is earlier.
3. The candidates may elect to draw either the pay in the scale of the pay of the deputation post or their basic pay in the parent cadre plus admissible deputation.
4. The option of the pay has to be exercised within one month from the date of joining. Option once exercised shall be final.
