#### परिपत्र /CIRCULAR

Senior Audit Officers willing to be considered for deputation to Central/State Government offices/Autonomous bodies/Public sector undertakings in Tamil Nadu and other States for Panel Year 2021-22 may give their willingness in the prescribed proforma, through proper channel on or before **27.08.2021** to Administration II section. The list will normally be valid for one year. The Officers working in the Office of the AG(Audit-II), TN & Puduchery and PDA(Central) should submit the filled in proforma to their respective Offices and the same is to be forwarded with the recommendations of the Accountant General/Principal Director of Audit (Central), Chennai.

The applicant should not have crossed the age of 56 years on the closing date of receipt of applications. It is to be noted that an Officer who declines to proceed on deputation after selection will be barred from further deputation for a period of one year.

Officers who have come back from deputation outside IA&AD will not be considered for any other deputation before he/she completes <u>three years</u> of cooling-off period. It should also be noted that the period of deputation will not, normally exceed four years in or outside IA&AD.
