
NOTICE

Applications are invited from retired Sr. Accounts Officers/ Sr. Audit Officers, Accounts Officers/ Audit Officers, Assistant Accounts Officers/ Assistant Audit Officers to work as consultant on short term contract basis against the four (04) vacancies in the cadre of Assistant Accounts Officer in the office of the Principal Accountant General (A&E) J&K in accordance with terms and conditions prescribed by Headquarter's office from time to time. The following broad terms and conditions are applicable to the contractual officers:-

1. Age should not be beyond 64 years as on 31.08.2021.
2. Retired person would be initially appointed for a period of 11 months, extendable up to a maximum of three terms of 11 months each which is subject to performance and requirement of service.
3. The retired persons engaged on short terms contract basis shall be paid fixed contractual payment of Rs.34,500/-per month. Besides, 50% of each increase in Dearness Allowance as per Headquarter's Office letter No. 763-Staff (App)/22-2016 dated 27.05.2019, will be passed on to the retired officials hired on contract basis. The consultant will not be entitled for house rent allowances, residential accommodation and transport allowance.
4. Statutory deductions levied by the Union/State Government shall be made as per rules.
5. The consultant will be eligible for 10 days leave (08 CL and 02 RH) in a calendar year on pro-rata basis. They will not draw any remuneration in case of his/her absence beyond 10 days (08 CL and 02 RH) in a year calculated on pro-rata basis. Un-availed CL/RH will not be carried forward to next year. If they are required to attend the office on Saturday/Sunday and other holidays in exigencies of work, they will not be paid any additional remuneration.
6. Absence during curfew, strike, bandh will be dealt with as in case of serving officials. Any absence on working days in a month for reasons other than above will be liable for deduction of his/her remuneration on pro-rata basis.
7. It may be noted that the appointment will be purely on temporary basis subject to termination at any time.

Interested retired officers of the IA&AD, fulfilling the eligibility criteria and willing for above assignment may submit their Bio-data. Applications duly filled in all respects must reach the undersigned either by post or through e-mail at agaejammukashmir@cag.gov.in latest by **31.08.2021**.
