Grant of relief on pension / family pension @ 28% w.e.f 01/07/2021 to the retired Judges of High Courts/Supreme Court and family pensioners of such Judges

In continuation to this office circular No Pen.Co-ordn./66 Vol.III/110 dated 14/11/2019, it is stated that Government of India, Ministry of Law and Justice (Department of Justice) vide their letter No L-19016/01/2018-Jus. dated 03/08/2021 have granted revised rate of Dearness Relief @ 28% with effect from 01/07/2021 to the retired Judges of High Courts/Supreme Court and family pensioners of such Judges in supersession of the existing rate. The increase subsumes the additional installments arising on 01/01/2020, 01/07/2020 and 01/01/2021. The rate of Dearness Relief shall remain at 17% of the basic pension / family pension for the period from 01/01/2020 to 30/06/2021.

The payment of dearness relief involving a fraction of rupee shall be rounded off to the next higher rupee.

All concerned Pension Disbursing Officers are, therefore, requested to make necessary arrangement for payment of Dearness Relief to the above categories of pensioners/family pensioners at the rate and from the date mentioned above.
