Pursuance to Memo No. Trg & Exam/02/01/2021-22/139 dated 02.09.2021, Departmental examination for Directly Recruited Auditors, Auditors promoted from Clerk Cadre, Graduate Clerks (ST/SC Categories) and Graduate MTS (Gen/SC/ST categories) is to be held in September, 2021.

All directly recruited Auditors who have completed one year of continuous service, Auditors promoted from Clerk Cadre on seniority basis on completion of 90 days of continuous service as Auditors, Graduate Clerk (ST/SC Categories) and Graduate MTS in Audit Offices who have completed three years of continuous service as on **01.08.2021** are eligible to appear in this Departmental Examination for Auditors.

Eligible candidates are requested to submit their applications in the enclosed formats to the Training & Examination Section (Au-II) **on or before 08.09.2021**. Applications received after due date will not be entertained under any circumstances.

Sub:- Calling for applications for Departmental Examination for Auditors- to be held during September-2021.

The Departmental Examination for directly recruited Auditors, Auditors promoted from Clerk cadre, Graduate Clerks (SC/ST categories) and Graduate MTS (Gen/SC/ST categories) is to be held in the month of September- 2021.

All directly recruited Auditors completing one year of continuous service, Auditors promoted from Clerk cadre on seniority basis on completion of 90 days of continuous service as Auditor, Graduate Clerks (SC/ST categories)/Graduate MTS in Audit offices with three years of continuous service as on 01.08.2021 are also eligible to appear in this Departmental Examination for Auditors for being considered for promotion against the promotion quota.

As per instructions contained in para 9.4.2 of revised Chapter IX M.S.O. (Admn), Clerks promoted to Auditor cadre may take examination immediately after their promotion. However, they may not appear the examination, if it is held within 90 days of their promotion. They may instead appear their first examination immediately thereafter. They (Clerks) have to pass the examination within six chances in six consecutive examinations held after they are eligible. Failure to pass the departmental examination within the stipulated/number of chances would entail discharge from the service in the case of direct recruit and reversion to Clerks Grade in the case of promoted Auditors. The reverted Clerks will have three more chances to clear this examination within two years of the reversion.

As per revised para 9.4.4 of Chapter IX of C&AG MSO (Admn.).Vol - I dated 20.02.2014, Principal Accountant General/Accountant General/Principal Directors of Audit may at their discretion, condone deficiencies in the prescribed service of one year in respect of directly recruited Auditors and in prescribed service of three years in respect of Graduate (Clerks/MTS) **up to a limit not exceeding two months**. Hence, directly recruited Auditors and Graduate Clerks/MTS having deficiency in the prescribed services up to a limit **not exceeding two months** as on the **crucial date i.e. 01.08.2021** may apply separately to the Accountant General (Au-I) for condonation of such deficiency in qualifying service.

Failure to appear for the above examination or absent from the examination for whatever reasons will also be taken as a chance availed of as per instructions contained in Para 9.4.2 of Chapter IX of MSO (Admn.), Vol - I (Revised 3rd Edition).

Applications in the prescribed Proforma (enclosed) may be submitted through proper channel so as to reach at the Training & Examination (Au-I) Section on or before **09.09.2021** Application Forms can also be accessed from office website cag.gov.in/ag1/Odisha/en & intranet site 192.168.0.253. All controlling Branch Officers are requested to circulate this circular.
