The Government of West Bengal, Judicial Department under their letter No. I/145438/2021 dated 17/08/2021, has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been enhanced from 164% to 189% with effect from 01/07/2021.

Co-ordn./65 Vol.IV/114 dated 20/11/2019, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ 189% to the above category of pensioners / family pensioners with effect from 01/07/2021 after proper adjustments of payment already made.

Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Charges for payment are debitable to the Govt. of West Bengal, under head 2071- Pension and other Retirement Benefits -01- Civil -101 Superannuation and Retirement allowances etc.
