In terms of Headquarters letter No. 101-Staff (Disc.)-17-2018 dated 31.03.2015, an annual return to Headquarters Office on cases of sexual harassment against working women pertaining to the period from 1st April to 31st March each year, is to be sent in the prescribed proforma. The Committee is requested to furnish details of number of complaints received, disposed of and action taken in the each case, to the Administration Section of this Office for preparation of a monthly report to Headquarters Office as required under Office Memorandum dated 22.12.2016 issued by Department of Personnel & Training, Government of India.

While discharging its functions, the Committee shall follow applicable Act/Rules and instructions/guidelines issued by the Headquarters Officer and Department of Personnel & Training, Government of India from time to time.
