In continuation to this office circular No. Pen. Co-ordn./Goa/Vol.-V/DR/135 dated 17-12-Order No. 12/3/82-2019, this is to state that the Government of Goa in their Fin.(R&C)/Vol.1/1693 dated 09-08-2021 has sanctioned dearness relief to their pensioners/family pensioners including Ex-gratia pensioners drawing pensions under C/B/D & E series, Pensao de Sangue pensioners, pensioners receiving pension under triple benefit scheme, recipients of Exgratia i.e. families of deceased pensioners who were governed under EFU, pensioners sanctioned pension under Education Act 15 of 1985 and drawing pension under series T and E.B., at the rate and from the date as under:

Date of effect Rate of Dearness relief per month
01-07-2021 28% of revised basic pension/family pension

- 2) This relief is not admissible to the Freedom Fighter pensioners, pensioners drawing pension which is granted after Independence for Political consideration (Ex-Rulers), MLA pensioners and Retired High Court and Supreme Court Judges for whom order will be issued separately by administrative authorities concerned.
- 3) Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4) Having been authorised by the Director of Accounts, Goa in their letter No. DA/PA-I/Pens/2021-22/TR-357/DR-464 dated 12-08-2021, it is requested to make necessary arrangement for payment of dearness relief to all eligible Goa Government pensioners/family pensioners mentioned above @ 28% on their basic pension/family pension with effect from 01-07-2021 after proper adjustment.
- 5) The charges on this account are debitable to the head "8793-LS.S. A/es.; Government of Goa etc."
