OFFICE ORDER

As per Exam Wings' Circular No. 10 of 2020 Letter No. 370/04-Exam/MSO Chapter 9-Revision/2020 Dated 15th October 2020 and Circular No. 11 of 2020 No. 75/03-Exam/Addl. Chance/2016/Vol. I dated 19th October 2020, the SAS/RA/I/CPD Main and Supplementary SAS/RA/I/CPD Examinations has been renamed as **Examination-1 and Examination-2 of the year. The cut-off dates for determining the eligibility of the officials for SAS/RA/I/CPD Examinations will be 1st March for Examination-1 and 1st September for Examination-2 of the year.**

The Preliminary Test for the SAS Examination-1 and the Examination-2 of the year 2022 is to be held on **02.12.2021 & 03.12.2021**. All the eligible candidates who intend to appear in the SAS Examination in 2021 has to successfully clear the Preliminary Exam.

There will be 02 Papers for Preliminary Exam :-

Paper - 1 General English/Hindi, Presis Drafting & Constitution of India

Paper – 2 Fundamental Rules, Service Rules & Principles of Government Accounting

The application forms in the prescribed format, to appear in the Preliminary Test can be downloaded from the office website (<https://cag.gov.in/ae/allahabad/en/page-ae-allahabad-examinations>). The filled in application forms can be submitted in the Examination section **latest by 01.11.2021** on any working day.

- 1) The following candidates who will complete 02 years of regular service in the office along with their probation period as on 1st March & 1st September will be eligible to appear in the Examination-1 or the Examination-2 of the year 2021 accordingly :-
 - i. Clerks who have successfully cleared the Type Test. (Level – 2)
 - ii. Stenographer-II/Data Entry Operator Gr. 'A' (Level – 4)
 - iii. Accountants / Data Entry Operator Gr. 'B' (Level – 5)
 - iv. Sr. Accountant/Stenographer-I/ Data Entry Operator Gr. 'D' /JHT (Level – 6)
 - v. Pvt. Secretary / Data Entry Operator Grade 'E' (Level – 7)
 - vi. Eligible officials who have either exhausted their twelve chances or eight years whichever is earlier from the first registration of CBT are also eligible to appear afresh.
 - vii. Eligible officials who could not pass five papers within the first (normal) six chances will also be allowed to appear afresh.
- 2) The Preliminary Test will be bilingual.
- 3) All the Divisional Accountants (Level – 6) & Divisional Accounts Officer (Grade II)(Level – 7) of O/o AG(A&E)-II, U.P. Allahabad who intend to appear in the SAS Examination-1 and the Examination-2 of the year 2022, should send their applications to WM section of O/o A.G.(A&E)-II, U.P. Allahabad, who will check and send a single compiled list of eligible candidates to Exam section latest by 24.12.2021 so that their names could also be included in the mandatory Training list. No names will be considered after the last date.
