Govt. of India has granted Non-Productivity Linked Bonus (Ad-hoc Bonus) for the accounting year 2020-21 to all Central Govt. employees in Group C & Non-Gazetted Group B. Only those employees who were in service as on 31.03.2021 and have rendered at least six months continuous service during the year 2020-21 will be eligible for bonus payment. Bonus amount is Rs.6908 (7000x30/30.4). The CAG of India, in their letter second cited, have issued orders for implementation of the orders of GOI first cited.

Divisional Accounts Officers (Gr. II) & Divisional Accountants of this office attached with PWD Divisions, Tamil Nadu are eligible for bonus payment. The names of eligible DAs are given in the Annexure.
