Applications in the enclosed proforma are invited from the retired Senior Audit Officers/Audit Officers/Assistant Audit Officers of the Indian Audit and Accounts Department willing to work as Consultants in the post of Assistant Audit Officer (Civil) in the office of the Accountant General (Audit), Meghalaya, Shillong, in accordance with the terms and conditions prescribed by Headquarters office vide Circular No. 27/2021 issued vide letter No. 967-Staff (App-1)/22-2016 dated 3rd August 2021. The vacancies proposed to be filled up are as under :-

25 % of vacancies in the Senior Audit Officers/ Assistant Audit Officers 'cadre, i.e. 25 % of 15 = 3.75 say 04.

Terms and Conditions :-

1. Age should not be beyond 65 years as on 01.12.2021.

2.Initial term of engagement shall be for a period of one year from the date of joining the post, which is extendable upto a maximum of five terms subject to performance of the official and requirement of service.

3. Remuneration and allowances payable to retired officers/officials will be governed by OM No.3-25/2020-E.III A dated 09.12.2020 issued by the Department of Expenditure, Ministry of Finance, Government of India, New Delhi, which is as under:

(a) A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of retirement of contract.

(b) An appropriate and fixed amount as transport allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.

(c) No annual increment/percentage increase, Dearness Allowance and House Rent Allowance shall be allowed during the contract.

4. Paid leave of absence shall be allowed at the rate of 1.5 days for each completed months of service. Accumulation of leave beyond a calendar year shall not be allowed. However, absence during curfew, bandh, strike, lockdown shall be dealt with in a similar way as in the case of serving officers/officials as these are events beyond the control of any individual.

5. If retired officers/officials hired on short term contract basis remain absent beyond paid leave in a month for reasons other than those indicated above, his/her remuneration shall be deducted on pro-rata

6. Statutory deductions of levies of the Union/State Government shall be made as applicable under the prevailing leaves and regulations.

7. The retired officers/officials selected to be hired on short term contract basis shall sign an agreement of confidentiality containing requisite clause/s on Ethics and Integrity.

8. The appointment on short term contract basis shall be purely on temporary basis and is subject to termination at any time.

9. Accommodation in the IA&AD Estate, if available, could be provided to the retired officers/officials who are selected to be hired.

Applications are invited from retired officers/officials of IA&AD fulfilling the eligibility criteria and willing for the assignment as per the terms and conditions stated above in the enclosed proforma duly filled in all respects, biodata and copies of their APARs for last five years if available with them must reach the under signed by name either by post or through email at agauMeghalaya@cag.gov.in.
