Subject: Grant of dearness relief to the Manipur Government pensioners/family pensioners with effect from 01-10-2021, 01-04-2022, 01-06-2022 and 01-12-2022.

In continuation to this office circular No. Pen. Co-ordn./Manipur/Vol.-V/DR/73 dated 19-10-2020, this is to state that the Government of Manipur in their Memo No. 2/6/2010-FD(PIC)(Pt) dated 01-10-2021 has sanctioned dearness relief to their pensioners/family pensioners at the rate and from the date as under:

Date of effect	Rate of dearness relief per month
01-10-2021	14% of basic pension/family pension
01-04-2022	17.5 % of basic pension/family pension
01-06-2022	21 % of basic pension/family pension
01-12-2022	28% of basic pension/family pension

- . The above dearness relief will also be admissible on the additional basic pension/additional family pension available to older pensioners/family pensioners based on their age.
- 3. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4. Other provisions governing grant of dearness relief in respect of employed family pensioners and re-employed Manipur Government pensioners will remain unchanged.
- 5. Having been authorized by the Principal Accountant General (A&E), Manipur in their letter No. Pen-1/MAN-MA/2020-21/1542/SSA/280 dated 29-10-2021, it is requested to make necessary arrangement for payment of dearness relief @ 14%, 17.5%, 21% and 28% on pension/family pension of such pensioners/family pensioners with effect from 01-10-2021, 01-04-2022, 01-06-2022 and 01-12-2022 respectively as per instructions laid down above and after proper adjustment.
- 6. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Manipur etc."
