#### **CIRCULAR**

Sub - Calling for applications from fresh / repeater candidates intending to appear in Subordinate Audit/Accounts Service (SAS)/RA/CPD-I, II & III Examination-**II** of 2021.

In terms of Headquarters office Circular No. 10 of 2020 issued vide No 370/04-Exam/MSO Chapter 9-Revision/2020 dated 15.10.2020, Circular 11 of 2020 issued vide No-75/03-Exam/ Addl chances/2016/ Vol- I, dated-19.10.2020 applications in the prescribed proforma (enclosed) are invited from eligible fresh / repeater candidates intending to appear SAS/RA/CPD-I/II/III Examination-2 of 2021. The cut off dates for determining the eligibility of the officials for SAS/RA/CPD I, II & III Examination is 1<sup>st</sup> September 2021 for Examination 2 of 2021 unless otherwise notified by the competent authority in a particular year.

Eligibility criteria for SAS: The existing candidates & the candidates who have passed the SAS preliminary examination held in Aug-2021 are eligible to appear said exam. Repeater candidates of the SAS Examination may follow the Examination Wing Circular 11 of 2020 issued vide No-75/03-Exam/ Addl chances/2016/ Vol- I, dated-19.10.2020, prior to submission of their applications.

**Eligibility criteria for RAE**: One year of continuous service in Revenue Audit Branch as SAO/AAO or after having attended the prescribed training in Revenue Audit.

**Eligibility criteria for CPD-I**: AAOs who have completed four years of continuous service in the Grade and all SAOs.

Eligibility criteria for CPD-II: SAO/AAOs who have qualified in the CPD-I (Suppl) Exam conducted on or before March-2017 or after 04 years from qualifying the CPD-I.

Eligibility criteria for CPD-III: SAO/AAOs who have qualified in the CPD-II (Suppl) Exam conducted on or before May-2018 or 03 years from qualifying the CPD-II test.

As per Circular 3 of 2021 issued vide Headquarters Lr. No. 159/03-Exam/ Addl Chance 2016 Vol.I dt 13.04.2021, two additional chances as a onetime opportunity is available to all the existing candidates of Rev. Audit & CPD-I&II examinations who have exhausted permissible six chances with effect from Examination -1 of 2021.
