*Subject : Grant of Temporary Increase (dearness relief) to the
Gujarat Government pensioners/family pensioners
with effect from 01-07-2021.*

In continuation to this office circular No. Pen.Co-ordn./Gujarat/Vol.-VI/DR/114 dated 20-01-2021, this is to state that the Government of Gujarat in their FD Resolution No. HGV-102017-O-450-P dated 14-10-2021 has sanctioned Temporary Increase (dearness relief) on revised pension/family pension of their pensioners/family pensioners as under:

Date of effect	Rate of Temporary Increase <i>per month</i>
01-07-2021	28% of basic pension/family pension

2. Temporary Increase at the rates indicated in above table will also be admissible on the additional basic pension/family pension available to older pensioners/family pensioners based on their age.
3. Payment of Temporary Increase involving a fraction of a rupee shall be rounded off to the nearest lower or higher rupee.
4. Other provisions governing grant of Temporary Increase to pensioners such as regulations of dearness relief during employment/re-employment, regulation of Temporary Increase, where more than one pension is drawn etc. will remain unchanged.
5. The Temporary Increase at the aforesaid rate will be paid regularly with the monthly pension/family pension and the difference of August-21 will be paid along with the pension of January-22. Rate of Temporary Increase from 01-01-2020 to 30-06-2021 will remain 17%.
6. Having been authorised by the Principal Accountant General (A&E), Gujarat in their letter No. Pension/G.R/Special Seal/01/2021-22/OW No. dated 12-11-2021, it is requested to make necessary arrangement for payment of Temporary Increase to all eligible Gujarat Government pensioners/family pensioners on their revised basic pension/family pension @ 28% with effect from 01-07-2021 after proper adjustment.
7. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Gujarat etc."
