OFFICE ORDER

Sub:- Pre-Exam. Training to SAOs/AAOs for CPD Examination April 2022 and onwards.

In pursuance of Headquarters' office training division email dated 14/01/2022, it is to intimate all SAOs/AAOs that C&AG of India has desired to provide pre-examination training to those who are willing to appear for CPD Examination to be held in April 2022 and onwards.

The training will be organized online for CPD papers involving in-house and external training partners.

The other instruction relating above mentioned email are as under-

(I) The scheme of pre-examination training will be applicable from CPD Examination-I of 2022 onwards.

(II) The scheme of pre-examination training is for all SAOs/AAOs who intend to appear in CPD examinations to be held in April 2022 and onwards.

(III) Only those SAOs/AAOs who have registered for the CPD examination will be provided the said training.

(IV) The pre-examination training for each paper of CPD Examination will be provided only once, irrespective of whether candidate appears in the CPD Examination or not.

(V) The training completion certificate will have to be mandatorily sent to Examination wing and Training, Headquarters'. Hence, all eligible candidates are requested to send a copy of training completion certificate to the training and exam section after completion of the training.

(VI) SAOs/AAOs who are willing to appear in the ensuing CPD Examination to be held in April 2022 may give their willingness to training and Exam section through Google form latest by 20/01/2022. Link of Google form is given below-

(VII) Field offices have to create paper-wise training course for each batch of pre-examination training of SAI Training portal as it will be done for in-house training courses.

(VIII) Nomination and registration of participants for the pre-examination training have to be done through SAI Training Application only.
