- ii. It is for all SAOs/AAOs who intend to appear in CPD examinations to be held in April 2022 and onwards.
- iii. The training for each paper will be provided only once, irrespective of whether the candidate appears the Examination or not.
- iv. Nomination and registration of participants for the pre-examination training should be done through SAI Training Application only.

Hence, all the eligible Sr. AOs / AAOs of the Office of the Accountant General (Audit-I) intending to enrol in the proposed training programme and appear the above examinations scheduled to be held in April 2022 may submit their willingness through their Controlling sections to Trg & Exam Section (Au I), duly filled in, in the prescribed pro-forma (enclosed) latest by **21.01.2022 (5PM)**.
