Sub Calling for applications / willingness from eligible fresh / repeater candidates intending to appear at the ensuing CPD-I and CPD-II Examination-I of 2022 tentatively scheduled to be held in April 2022 – reg.

This refers to OOC-837 dated 18.01.2022, in respect of the subject cited above, the following points have subsequently been clarified by Training Division of Headquarters.

- i. Pre-examination training for CPD examination is **not** mandatory for appearing in the CPD Examination of 2022 and onwards.
- ii. The pre-examination training for each paper of CPD examination will be provided to the candidate only once, irrespective of whether he/she appears in the CPD examination or not.
- iii. All SAOs/AAOs who intend to appear for the CPD examination - I and CPD examination-II of 2022, will be provided the said training. However, pre-examination training of CPD examination 2022 will be conducted only once for CPD Examination- 1 and Examination-2.

In view of the above clarification issued, it is requested that all Sr. AOs/ AAOs who are willing and eligible for registration of both CPD-1 and CPD-II Examination 1 & 2 of 2022 may avail the said training facility. The cut-off dates for CPD Examination-1 and CPD Examination-II of 2022 is 03.03.2022 and 01.09.2022 respectively.

All other contents of the OCC837 dated 18.01.2022 referred to above remain unchanged.
