

The C&AG of India had desired to provide pre-examination training to SAOs/AAOs appearing for CPD Examination to be held in April 2022 and onwards.

2. In view of the above direction, the Training Wing, has firmed up an action plan for pre-examination online training for CPD papers involving in-house and external training partners.

3. The paper-wise action plan for pre-examination Training is summarised below:

4. In this regard, all the field offices are requested to adhere to the following instructions:

- i. The scheme of pre-examination training will be applicable from CPD Examination-I of 2022 and onwards
- ii. The scheme of pre-examination training is for all SAOs/AOs who intend to appear in CPD examinations to be held in April 2022 and onwards.
- iii. Only those SAOs/AOs who have registered for the CPD examination will be provided the said training.
- iv. The pre-examination training for each paper of CPD Examination will be provided only once, irrespective of whether the candidate appears in the CPD Examination or not.
- v. The training completion certificate will have to be mandatorily sent to Examination Wing and Training Wing, Headquarters
- vi. Field offices have to prepare paper-wise list of SAOs/AOs who have given their willingness to appear in the ensuing CPD Examination to be held in April 2022.
- vii. Field offices should create paper-wise training course for each batch of pre-examination training on SAI Training portal as is being done for in-house training. (The help file for creating in-house trainings on SAI Training Portal is attached for reference)
- viii. Nomination and registration of participants for the pre-examination training should be done through SAI Training Application only.

5. Keeping in view the points mentioned at para 4, all Heads of field offices are requested to do the following under intimation to Training Wing/Headquarters ([trgwing@cag.gov.in](mailto:trgwing@cag.gov.in))

- a. conduct online training for C-2 paper (Accounting and Auditing Principles & Standards) of CPD – I Examination in-house preferably from 31<sup>st</sup> January 2022. However, the office should schedule the said training in such a way that the training gets completed by 31<sup>st</sup> March 2022.
- b. send the list of SAOs/AOs appearing in C-6 paper (Information System Audit) of CPD-III Examination to iCISA Noida ([icisa@cag.gov.in](mailto:icisa@cag.gov.in)) latest by 25<sup>th</sup> January 2022
- c. send the list of SAOs/AOs appearing in C-1 (Financial Management) of CPD - I and C-3 (Public Finance) of CPD - II Examinations to the nodal officer, AJNIFM ([rajeshkagrawal@nifm.ac.in](mailto:rajeshkagrawal@nifm.ac.in)) latest by 25<sup>th</sup> January 2022
- d. send the list of SAOs/AOs appearing in C-4 (General Principles of Economics) of CPD - II and C-5 (General Studies and current Economic Developments) of CPD - III Examination to the nodal officers, OP Jindal Global University ([dvashisht@jgu.edu.in](mailto:dvashisht@jgu.edu.in)) latest by 25<sup>th</sup> January 2022
- e. Nominate a nodal officer from your office for correspondence with the Training partners as well as the Training Wing, Headquarters.
