CIRCULAR

Sub: Calling for application from the intending candidates to appear Preliminary Test in order to qualify for forthcoming SAS Examination -1 & 2 of -2022 (Civil & Commercial Branch)

Applications are invited from eligible officials under the cadre control of Accountant General (Au-I) Odisha, who intend to appear the SAS Examination 1 & 2 of 2022 (Civil & Commercial Branch), to apply for the Preliminary Test to qualify for the Examination. They may submit their applications in the prescribed proforma appended to this circular through proper channel so as to reach the Trg. & Exam. (Au-I) Section on or before 15.02.2022 positively.

(i) The following categories of officials who have put in a minimum two years of continuous service in one or more of the following capacities and who would be successfully completing probation period on or before 1st March and 1st September 2022 for SAS 1 & SAS 2 Examinations 2022 respectively are eligible to appear the Preliminary Test for qualifying the SAS Examination 1 & 2 of 2022. In case of failure to complete the probation period successfully by due date, the candidature of such officials would be cancelled.

- a) Clerks (Level-2 of Pay Matrix) passed Departmental skill Test.
- b) Auditors / Senior Auditors/Assistant Supervisors (Level-5, 6, & 7 of Pay Matrix respectively)
- c) Data Entry Operator Grade-'A', 'B', & 'D' (Level-4, 5, & 6 of Pay Matrix respectively)
- d) Stenographer Grade-I, Grade-II & Private Secretary (Level 4,6 & 7 of Pay Matrix respectively)
- e) Junior Translator/Senior Translator (Level 6 & 7 of Pay Matrix)
- f) Supervisors (Level-8 of Pay Matrix)

(ii) In accordance with Note 3(iii) of revised chapter IX para 9.2.6 of MSO (Admin) Vol.-I, **Supervisor** (Pay level 8) cadre officials will be eligible to appear at SAS Exam subject to the condition that in the event of their passing the SAS Examination they will have to seek reversion in writing to the posts of Senior Auditors. **The undertaking is to be given in writing before sitting for the Examination.**

(iii) A candidate who had qualified in the last Preliminary Test but was absent or had withdrawn his/her candidature from the immediate next SAS Examination will be required to appear the test again to have eligibility to appear in subsequent SAS examination.

(iv) As per Hqrs. Office Examination Wing Circular No.11 of 2020 issued on 19/10 2020, the eligible and intending officials

- a. are to appear the Preliminary Test for the SAS Examination after exhausting either 12 chances or 08 years whichever is earlier from the first registration of CBT.
- b. who could not pass five papers within the first(normal) six chances will also be required to appear the Preliminary Test

(v) All the fresh candidates who will come out successful in Preliminary Test will have to undergo and complete the prescribed pre-examination training. There shall be two papers for the Preliminary Test and the pattern of the test will be of Multiple Choice Questions (MCQ) except for the Language Skills (English/Hindi) portion.

(vi) The applications of the candidates belonging to PAG (Au-II) and Director (CRA) establishment should be routed through respective Admin. Groups after verifying authenticity of the information. Application complete in every aspects should reach the AG (Au-I) T&E section on or before 15/02/2022. Incomplete applications will be summarily rejected.

The date of Preliminary Test including the detailed programme, Venue of the Test and list of eligible candidates will be notified in due course.
