## कार्यालय आदेश

मुख्यालय कार्यालय से प्राप्त पत्र संख्या- 85-स्टाफ (जे सी एम)/10-2022 दिनांक-31.01.2022 द्वारा सूचित किया गया है कि All Major Central Trade Unions of India have decided to organize two days nationwide strike in pursuance of their charter of demands. Confederation of Central Government Employees & Workers, New Delhi endorsed the decision of the Central Trade Unions and has decided to participate in the two days strike on 23<sup>rd</sup> and 24<sup>th</sup> February, 2022.

All India Audit & Accounts Association, which is an affiliate of Confederation of Central Govt. Employees & Workers, New Delhi endorsed the decision of Confederation of Central Government Employees & Workers to participate in the aforesaid two days strike.

In this regard it is to hereby inform all the officers/officials of this office that under Rule 7 of CCS (Conduct) Rules, 1964. No Government servant shall – (i) engage himself or participate in any demonstration which is prejudicial to the interests of the sovereignty and integrity of India, the security of the State, friendly relations with foreign States, public order, decency or morality, or which involves contempt of Court, defamation or incitement to an offence, or (ii) resort to or in any way abet any form of strike or coercion or physical duress in connection with any matter pertaining to his service or the service of any other Government servant.

The Government of India, Ministry of Home Affairs OM 25/23/66-Ests(A) dated 09.12.1966 has clarified the term “Strike” by way of demonstration to mean refusal to work or stoppage or slowing down of work by a group of employees acting in combination and includes mass abstention from work without permission, refusal to work over time where such work is necessary in public interest, resort to practices or conduct which is likely to result in or results in the cessation or substantial retardation of work in any organization. Such practices would include, what are called ‘go slow’, ‘sit-down’, ‘pen-down’, ‘stay-in’, ‘token’, ‘sympathetic’ or any other similar strike; as also absence from work for participation in a Bandh or any similar movements.

The Government of India has also clarified that holding of demonstration/meeting without permission within office premises is strictly prohibited and any such meeting would be treated as a violation of the Rule 7 of the CCS (Conduct) Rules.

Any Government servant engaging himself or participating in any demonstration/meetings in violation of the instruction and / or resorting or in any way abetting any form of Strike, is required to be viewed seriously. Action under the provisions of FR 17 and FR 17 A for unauthorized absence may be taken. Such employee also rendered themselves liable for a departmental action under the CCS (CCA) Rules, 1965.

In view of the above, it has been decided that **any kind of leave will not be sanctioned now for the day of 23<sup>rd</sup> and 24<sup>th</sup> February, 2022 to anyone.** However, in special circumstances, if it will be considered necessary to be sanctioned, the same will be decided only by the Sr. Dy. Accountant General (Administration) on whatsoever grounds. The Group Officers/Branch Officers' in charge of concerned officials will not be authorised to sanction any sort of leave applied for 23<sup>rd</sup> and 24<sup>th</sup> February, 2022.

The officials are, therefore, directed to attend office on the said date on scheduled time and maintain office decorum, failing which action against them may be taken according to the relevant rules.

It is, also, directed that every activity and movement of the officials on the said date should be watched by the Controlling Authority of Wing concerned and also if any employee is found absent on 23<sup>rd</sup> and 24<sup>th</sup> February, 2022, it may be reported to the Confidential Cell latest by 28<sup>th</sup> February, 2022 so as the report received may be sent to the Headquarters office in time. In case no official is found involved in any activity, the 'Nil' report may be submitted.
