OFFICE ORDER

In terms of Rule 18 (1) (ii), GID (16) of CCS (Conduct) Rules, 1964, all Government servants belonging to Group 'A', 'B', 'C' officers shall submit an annual return "as on 31st December" every year giving full particulars of immovable property inherited/ owned/ acquired/ held by them, on lease or mortgage either in their own name, or in any of their family member's name, or lease or in any other person's name. Government servants are required to file their returns by 31st January, in the prescribed forms in terms of Rule 18(4) of the CCS (Conduct) Rules.

But, it has been observed that a large number of officials have not submitted the same till date. Officials who have not furnished the Annual Immovable Property Returns for the year 2021, in terms of CCS (Conduct) Rules, 1964, may send the same manually/ scanned copies through e-mail in the prescribed proforma.

Failure to submit the Annual Property Return by 31st January shall entail denial of vigilance clearance and the persons concerned shall not be considered for empanelment for senior level posts in Government in terms of Rule 18, GID 30.

Therefore, all the officers/ officials under Divisional Accountant Cadre including those who are on deputation are instructed to submit the immovable property statements for the year 2021 in the prescribed proforma (copy enclosed) latest by 28.02.2022, failing which appropriate action will be taken.
